In all cases, both father, mother, legal guardian, or authorized person, by signing this document and presenting the photocopy of DNI/NIE/Passport, declare that they are fully aware of the conditions of purchase and sale of the tickets exposed to minors and accept them without restrictions. Likewise, he/she declares he/she fully and solely responsible for the protection and custody of the minor or minors mentioned in the document, committing to ensure his/her safety and well-being throughout the duration of the event he/she attends within the Festival de Cap Roig in Calella de Palafrugell (Girona).

In the same way, it approves the responsibility to prevent the consumption by the minors mentioned in this document of substances such as alcohol, tobacco or narcotics; and to avoid any situation of risk or danger to the child(ren) or that he/she may cause. In particular, special care will be taken in the custody of the child, during the celebration of the artistic performances, placing the minor(s) in safe places and always accompanied by him/herself.

Those responsible for the minors and they themselves exempt the company organising the event from any liability, both for the damages and/or losses that the minors may suffer as a result of their enjoyment of the concert (including among other hearing damages) or for any damage that they themselves may cause during their stay in the facilities, In any case, the father, mother, legal guardian or authorized person is the only person legally responsible for the aforementioned damages.

The authorised person firmly consents that the entity does not refund the amount paid to the minor and/or denies his/her entry to the venue, in the event of having failed to comply with any of the aforementioned conditions or of not having provided the correct and necessary documentation indicated by the Organiser of the event.
