To take responsibility for minors brought inside the venue during the celebration of the concert **Festival de Cap Roig concert in Calella de Palafrugell (Girona).**

In all cases, both the father, mother, legal guardian or authorized person by signing this document and presenting the photocopy of the DNI/NIE/Passport declares to be fully aware of the conditions of purchase and sale of the tickets exposed to/ minors and accepts them without restrictions.

Likewise, he/she declares himself/herself fully and solely responsible for the protection and custody of the minor or minors mentioned in the document, committing to ensure their safety and well-being throughout the duration of the event he/she attends within the **Festival de Cap Roig concert in Calella de Palafrugell (Girona).**

In the same way, it approves the responsibility to prevent the consumption by the minors mentioned in this document of substances such as alcohol, tobacco or narcotics; and to avoid any situation of risk or danger for the minors, or that he/she/themselves may cause. In particular, he/she will be especially diligent in guarding and custody during the celebration of the artistic performances by placing the minor/s in safe places and always accompanied by him/herself.

Those responsible for the minors and they themselves exempt the company organizing the event from any liability, both for all damages that the minors may suffer as a result of the concert (including, among other damages of hearing) or for those damages that they/themselves could cause during their stay in the facilities, being in any case the father, mother, legal guardian or authorized person the only legal responsible for the damages mentioned.

The authorized person firmly consents to the entity not returning the amount paid to the minor and/or refusing entry to the premises, in the event of breach of any of the aforementioned conditions or failure to provide the correct documentation and necessary indicated by the Organizer of the event.

In accordance with the provisions of article 6 of Ley Orgánica 3/2018, of December 5, on the protection of personal data and the guarantee of digital rights, you are informed that all the data that you have provided with the with due consent they may be processed in the responsibility files of Clipper's Live, S.L.

In the same way, we inform you of the possibility of exercising the corresponding rights of access, rectification, cancellation and opposition, by virtue of what is established in Ley Orgánica 3/2018 in front of Clipper's Live S.L. as to those responsible for the file.
